Oregon Plus One: During the year ended March 31, 2011, through our core service, the Oregon Plus One Program, Death with Dignity National Center lent its expertise in public policy analysis to citizens, public officials, and end-of-life experts interested in the Oregon and Washington Death with Dignity experience. We provided information about the latest statistics and research, and we provided data concerning implementation of the law. We provided resources regarding the law's impact on the medical profession, and we assisted with research and analysis of public policy data. Consistent with the goal of the program, we provided assistance and disseminated information to individuals in other states which are looking to enhance end-of-life care for the terminally ill.

Public Education: Through this program, we provided information and educational materials about the Oregon and Washington Death with Dignity laws to individuals nationwide. In addition, we responded to requests for information and provided referrals to terminally ill individuals and their family members about a wide range of end-of-life issues. We provided educational materials through our website, acting as a trusted resource for legal, medical and other scholarly research. Our Dignity Report provided more than 16,000 individuals with substantive articles, updates, and interviews during the year.

Communication: This program promotes Oregon's Death with Dignity law and other end-of-life care issues to a national audience through the media.
